**AY 2023-2024 Summary:** A program pass-rate of 80% or higher on the Teaching and Learning Portfolio (TLP) is expected for all initial programs. In total, 96.66% of initial program completers passed the TLP without revision and 3.33% of initial program completers passed the TLP with revision in fall 2023. In spring 2024 a new version of the TLP was adopted and 97.69% of initial program completers passed the TLP without revision and 2.83% of initial program completers passed the TLP with revision. One hundred percent of program completers passed the TLP, a requirement for program completion and licensure.
